COFA 5500/7500, Community Forest Management

This is a split-level, three-credit course taught every spring semester. It is required of all Community Forestry and Arboriculture (COFA) Area of Emphasis (AOE) students. The purpose of this course is to provide students with an understanding of sustainability, governance, planning, and assessment that

must be considered in urban tree management, and how these elements must be considered within the community's social and ecological contexts. Content and format were newly created for COFA students. Topics covered include: community development and planning, tree canopy and vegetation management, ordinances, tree inventories, tree appraisal and associated values, risk assessment and liability, maintenance cycles, disaster response, right of way management, recreational values, budgets and staffing, tree boards and volunteers, professional development, and sustainability goals. Therefore, this course helps future urban resource managers to understand, appreciate, and incorporate different aspects of ecological and human dimensions in their canopy-management decisions. Evaluation consists of quizzes and assignment, two exams, and a forest management plan that includes a limited tree inventory.

COFA 5001/7001, Urban Tree Management I

This split-level, three-hour course is co-taught with Dr. Kim Coder every fall semester. It is required of all COFA students. This course covers anatomy and physiology of urban trees, including tree growth and development, functions, morphology, ecological responses to external/internal changes. It also provides an overview of treatment prescriptions and applications in the landscape. Evaluation consists of two exams, a comprehensive final exam, and a final paper. Graduate students have more in-depth exams than undergraduates and must make a presentation.

COFA 5010/7010, Urban Tree Management II

This split-level, four-credit course is co-taught with Dr. Kim Coder every fall semester. It includes a weekly three-hour lab and is required of all COFA students. The class reviews tree planting, training, pruning, lightning protection, cabling & bracing, fertilization, survey of basic climbing, general tree problems, and construction damage as they apply to shade, street, park and right-of-way trees in community and urban forest sites. This course covers the national tree care standards of the United States and the International Society of Arboriculture best management practices for tree health care. It prepares students for international credentials as professional arborists and tree health care providers. Evaluation consists of two exams, a comprehensive final exam, and lab flow charts. Graduate students have more in-depth exams than undergraduates and must make a presentation.

FANR 4500S, Senior Project in Forestry and Natural Resources Management

This is a team-taught four-credit capstone service-learning course. In addition to advising student project teams, I started coordinating the course in fall semester 2020. Students demonstrate their knowledge and skills, including problem-solving, decision-making, and communication capabilities learned during their tenure at Warnell. Students work with actual stakeholders to solve a relevant natural resource problem such as a forest management plan. Students must collect and analyze data, and summarize results to make recommendations based on the best combination of biological, financial, legal, social, and ethical considerations. Students are evaluated on how effectively they work in a professional setting, including group work, analyses, ability to keep records, meet deadlines, and communication of ideas. In addition, students are graded on a final report submitted to their "client" and a final report presentation. The course format consists of weekly lectures and weekly meetings with two group advisors.

FANR 3400/3400D, Society and Natural Resources

This is a two-credit course taught every fall semester. It contains a discussion portion (i.e., "lab") in addition to lecture. The purpose of this course is to provide students with an introductory understanding of the social, political, and ethical aspects of making natural resource management decisions and the related consequences of those decisions for our natural resources. It examines how human values, sociocultural, and social structural contexts (e.g., gender, race, wealth, power) impact natural resource management. Learning objectives are designed around values, stakeholder participation, ethics, and

equity in natural resource management. Therefore, this course helps future resource managers to critically understand, appreciate, and incorporate different aspects of human dimensions in their land-management decisions. Students are evaluated using quizzes and assignments, one exam, discussion, and a final paper.

COFA 3900, Community Forestry and Arboriculture Internship

This is a team-taught three-credit course with instructors representing the various components of Warnell's majors. Students wishing to complete an internship for course credit are required to work for a sponsoring organization for 100 to 300 hours. Students must submit a written assignment and make an oral presentation. Employers complete an evaluation. Besides advising and evaluating students, instructors initiate internship paperwork with employers.

FYOS 1001, First-Year Odyssey Seminar

Taught twice to date at UGA. Entitled "Keeping it Green: Natural Resource Management for Cities and Towns," this one-credit seminar takes a multidisciplinary approach to introducing students to the world of community forestry – the management of single trees and groups of trees as well as associated water and soil resources in urban, suburban, neighborhoods, and small-town landscapes. Course topics address urban ecology, arboriculture, community development, recreation, urban wildlife conflict, governance, and community planning among others. Because UGA is a designated Tree Campus USA, students learn about many of these topics using campus as a living laboratory. In addition, students learn about the tripartite mission of the Land Grant University as well as the breadth of career opportunities in community forestry and arboriculture, including those that advance technology in computational, microbiological, and spatial sciences. Evaluation consists of quizzes and a final report with presentation.

Dr. Gordon's outreach appointment combines his disciplinary foundations in forestry and rural sociology to address the needs of stakeholders in natural resource management. His educational program has focused on community forestry and arboriculture. Example program topics include: *urban forestry inventory, urban tree measurements, tree risk assessment, tree identification and selection, landscape ordinances, urban forest planning, canopy benefits and management, GPS/GIS/UAV, climate variability, selection and establishment of trees, tree pruning, planting and establishment, soil management, tree biology, irrigation systems for trees, controlling invasive species, urban ecology, tree pest and disease diagnosis. Program formats consist of short courses, workshops, field days, seminars, and webinars. As well, he advises clients using office calls, site visits, email, and the Georgia Distance Diagnostic Service. Tables 1 and 2 provide an outreach instruction summary of facts.*
